## **MINUTES**

After discussion, it was moved by Kryss Rankin and seconded by Jill Cook that the Board adopt the resolutions of Appreciation. Said motion was unanimously carried.

<u>Strategic Planning.</u> The CEO/Risk Manager allowed the Board to discuss any trends, actions, or future risk management plans (Exhibit "O").
